

RRTA Proposed Bus Fares

The South Central Transit Authority (SCTA) announced proposed changes for RRTA bus fares at its March 18, 2020 Board Meeting.

**The new fares would take effect
Monday, August 24, 2020.**

Under the proposal, SCTA is simplifying the RRTA fare structure and eliminating the fare zones. It is proposed to only have a base fare zone. The cash fare would increase \$0.10 to \$1.80. The Adult 10 Ride Pass price would be \$13.50. The Adult 31 Day Pass would be \$42.00.

The proposed changes were presented to the SCTA Board and now to our customers, to ensure a full understanding of the proposal before it is approved.

Proposed Cash Fares

All proposed changes would go into effect on August 24, 2020. The present and proposed fares are shown on the following panel for your review:

Transfers

<u>Present</u>	<u>Proposed</u>

Customers will still need to request a transfer slip to use on the second bus when completing their trip but will not be charged for the transfer.

Proposed to require payment of all fares upon entry of the bus for all trips. Payment will always be when a customer boards the bus.
