A. Appointment of Solicitor for 2023

C. Approval of Management Agreement with South Central Transit Authority (SCTA)

The existing management contract with SCTA expired on June 30, 2022 after a one year extension of the initial five year agreement as part of the merger to create SCTA. A copy of the agreement is included in the Board packet for review that would extend the management agreement for another year period ending June 30 2023. The new agreement would be retroactive to July 1, 2022. Staff recommends approval.

D. Approval of Lease Agreement with South Central Transit Authority (SCTA)

As part of the management agreement with SCTA, a copy of the lease agreement for RRTA facilities is included in the Board packet for review. The lease provides for SCTA the authority to spend funds on the maintenance and operation of the facilities needed for service. The lease is for another year and will expire on June 30, 2023. The agreement is retroactive to July 1, 2022. Staff recommends approval.
