

Proposed Route and Schedule Changes for September 8, 2025

The following route & schedule changes have been proposed by South Central Transit Authority (SCTA) for Red Rose Transit bus service to be implemented on Monday, September 8, 2025. The proposed changes have been presented for approval based off compiled customer comments submitted through phone calls, emails, social media comments and outreach events. The proposed changes have been discussed and proposed from meetings with the 2025 Route & Schedule Team, consisting of Operator, Maintenance and Administrative Staff representation.

A description of the proposed changes is as follows:

Route 1 - Northeast/Southeast:

Propose to reroute the inbound portion of the route to travel from Reservoir Street to Lehigh Avenue to North Broad Street to avoid traffic at the intersection of Lehigh Avenue and North Franklin Street on current route.

Route 3 - Sterling Place/Kensington Court:

Propose to add an 8 PM trip leaving Queen Street Station Monday through Saturday.

Route 5/Golden Triangle:

Propose to serve Golden Triangle Shopping Center inbound only. Propose to add service to the Shoppes at Belmont after traveling to Lancaster Shopping Center.

Route 10/Lititz

Propose to make time point adjustments to improve on-time performance. Propose to add time to trips to address current late issues.

Route 13/White Horse:

Propose to make minor time point adjustments to improve on-time performance. Propose to adjust time points from Ewell Plaza in Downtown Lancaster to Bridgeport and also from White Horse to Cains.

Route 16/Millersville:

Propose to make time point adjustments to improve on-time performance. Propose to adjust time points from Queen Street Station to Columbia Avenue & Ruby Streets and also from Millersville Pike to Manor Center.

Route 17/Columbia:

Propose to make time point adjustments to improve on-time performance. Propose to add time to trips to address current late issues.

Route 18/Elizabethtown:

Propose to make time point adjustments to each trip servicing Zeager Road to improve on-time performance. Propose to add a time point in Elizabethtown Borough at East Summit & North Cherry Streets.
