1. Previous Action Item Status

- a. The KH team moved forward with analysis of one additional zone (Willow Street-Strasburg-Outlets). The analysis was used to update the round 2 prioritization in the Tasks 5 and 6 technical briefing deck
- b. What did SCTA learn from conversations with planners in the southern portion of the County?
 - i. Confirmed additional outreach not needed at this time as project team moved forward with additional analysis for Willow Street-Strasburg-Outlets zone, and several SC member represent the Quarryville area.
- c. Was there anything to note from the MPO meeting Lauri attended?
 - i. Lauri gave them a status update and let them know that the project team is refining the zones.

2. Technical Task Progress Update

- a. Task 1: Steering Committee
 - i. KH is finalizing responses to Steering Committee members based on our decision to analyze an additional zone.
 - ii. KH will send those responses to SCTA for review before sending to SC members.
- b. Task 3: Public Participation Plan
 - KH is continuing to plan the approach for next round of public outreach in the fall (November into December). The plan includes an in-person meeting or pop-up event, and materials will be created so the team can conduct additional outreach if needed.
 - ii. The approach document for this outreach will be shared soon, allowing the team to start considering potential locations and logistics, likely within the next week
- c. Task 5: Opportunity Zone Analysis and Task 6: Zone Prioritization
 - i. KH reviewed its analysis of the Willow Street-Strasburg-Outlets zone, which showed it performs similarly to the other priority zones.
 - ii. KH reviewed the updated round 2 prioritization results, which showed the additional zone ranked third.
 - iii. KH will share the updated and final Taks 5 and 6 deliverable with SCTA and SC the week of 9/22.





- d. Task 7: Recommendations and Task 8: Performance Monitoring
 - KH is finalizing the technical briefing deck based on discussion with SCTA regarding service model, recommendations, and performance monitoring.
 - ii. KH will complete the draft and share with SCTA by 9/26.
 - iii. KH will present the recommendations and performance measures to the Steering Committee on October 23 from 8:00am to 9:30am for an inperson meeting. Tyler to send a calendar invite encouraging in-person but offering virtual, if needed. Lauri to reserve the conference room.
